e. General Service Update

The Chief updated the Board on a police member involved in a single MVI, which occurred in the early hours of September 12th. The cause of the crash is currently being investigated. The member in stable condition and the Wellness team has been engaged for the support of both the members who attended the crash and the injured member's family.

CSPS swore in a new Recruit Constable, Marc Gosselin on September 6th. R/Cst. Gosselin started at the JIBC September 9th.

The Chief and others attended the JIBC grad for Cst. Murray Fyfe and Cst. Chris Ferguson in July.

Cst. Chris Magnusson and Cst. Anil Apa have both returned to patrol from their respective secondments.

Cst. Matt Ball has been promoted to Sqt, which took affect September 4th.

Sgt. Paul Brailey is the lead Sergeant for the CRD ICE unit which will have him on secondment for five years.

DC Hackett attended and chaired a roundtable event dealing with Sextortion.

DC Hackett presented updated stats to the Board, which detailed an increased amount of shoplifting to local businesses and an increase to traffic complaints which can be articulated due to enhanced enforcement. There has also been a general increase to mental health calls. The Board engaged in a general discussion regaqrding increased shoplifting to local businesses and their reporting structure. The stats showed that one again, Hospital wait times are increasing. There must be a change to the current legislation in order to see any significant change. The Chief advised that this topic is reoccurring at the Area Chiefs meetings, and that the Chiefs are looking at options as a group to apply pressure for a change.

CARRIED UNANIMOUSLY

The Chief and Deputy further updated the Board on their decision to pull out of several Integrated Units: Regional Domenstic Violence Unit (RDVU), Mobile Youth Services Team (MYST) and Integrated Mobile Crisis Repsonse Team (IMCRT). Stats over the years have shown that these resources are mostly distributed to the regions' core, and that the community of Central Saanich does not see the benefit for value from these units. The Westshore RCMP have already pulled out of these units. There has been discussion with local partners to discuss future plans to replace the services these units provide, which would also allow for growth and development of our own members.

Central Saanich remains low on the Crime Severity Index (CSI).

f. Financial Update

The overall budget is coming in at 67% which is on track for the 2024 year.

2. NEW BUSINESS

a. 2025 Budget Discussion - CFO Troy Ziegler

CFO Troy Ziegler presented the 2025 budget guidelines, and proposed 2025 budget. He advised the Board of the timeline for approval to meet Provincial obligations. The current drivers are increases to the Integrated Units budget, an increases to EComm, a budget for a new recruit, two casual administrative positions and an increase to FTE for a PTE civilian position. The 2025 budget is categorized as status quo, with 94% of the budget already predetermined, 81% of that is wages and benefits. The increases to the 2025 budget work out to \$64 per household.

The Board discussed the level of involvement in the creation of the police budget for future years.

The Chief and CFO Advised the Board that there may be an expansion of the Vancouver Island Intergrated Major Crime Unit (VIIMCU) which may impact future budgets significantly.
